General Guidelines to APA Citations

In-text Citations

- If the author is introduced in the text of your paper, include the date of the work right after the author's name and the page reference at the end of the sentence. If the author is not introduced in the text of your paper, include the author, date and page reference at the end of the sentence.

Windschitl, Thompson, and Braaten (2018) argue that "argument as a science practice is usually explored systematically only in classroom settings" (p. 201).

OR

While students certainly hear disagreements throughout their lives, "argument as a science practice is usually explored systematically only in classroom settings" (Windschitl et al., 2018, p. 201).

- Note how the end period falls after the parenthetical citation.
- Separate items in the citation by a comma.
- For **direct quotes**, include the author, date, and page number; for **referencing an idea**, include only the author and year.
- For works without an author, use the title; if the title is long, use a shortened version of it.

References

In an APA document, the list of works cited is titled "References." The list should be in alphabetical order by the first word in the citation. The style of the entries in your References list varies depending on the type of material it is.

- The current guidelines, released in 2019, specify using a DOI (Digital Object Identifier). While some online resources include this information, some do not yet. A DOI is a unique identifying number for articles, making it easy for others to find and reference.
- Do not include first names; use only initials.
- Spell out months in date information; do not abbreviate.

Notes: If the author is indicated as "Anonymous," use that term as if it were a real name; enter the work in your references list as "Anonymous."		
Book, Editor	(Riebe, 2018, p. 47)	Riebe, D. (Ed.). (2018). <i>ACSM's guidelines for exercise testing and prescription</i> . Wolters Kluwer.
Notes: For multiple editors, use the abbreviation Eds.		
Chapter in a Collection or Anthology	(Martinez, 2018, p. 422)	Martinez, G. A. (2018). Spanish in the health professions. In M. Lacorte (Ed.), <i>The Routledge handbook of Hispanic applied linguistics</i> (pp. 420-437). Routledge.
Notes: If there are multiple editors, list their initials and last names in normal, not reverse, order. Include the page numbers of the cited chapter or essay.		

Bible	(Rom. 3:23, New Revised Standard Version)	<i>The new Oxford annotated Bible (New Revised Standard Version)</i> . (2018). Oxford.
Notes: Rather than page numbers, include the book, chapter, verse(s), and translation. Sacred texts are included in the references list; do not include an author.		
Dictionary or Encyclopedia, Author	(Kumaraswamy, 2015, p. 287)	Kumaraswamy, P. R. (2015). Lebanon. In <i>Historical dictionary of the Arab-Israeli conflict</i> (2nd ed., pp. 286-289). Rowan & Littlefield.
Notes: If a specific edition is noted, include the edition number in parentheses after the title.		
Dictionary or Encyclopedia, Author and Editor	(Tischauser, 2015, p. 128)	Tischauser, L. (2015). Border patrol, U.S. In C. L. Bankston, III & D. A. Hidalgo (Eds.), <i>Issues in U.S. immigration</i> (Vol. 1, pp. 125-131). Grey House Publishing.
Notes: In a multi-volume work, include the volume number in parentheses after the title.

Dictionary or Encyclopedia, Electronic	(Barelle & Buratti, 2013)	Barelle, M., & Buratti, E. (2013). Protein splicing. In S. Maloy & K. Hughes (Eds.), <i>Brenner's encyclopedia of genetics</i> (2nd ed.). Elsevier Science & Technology.
Notes: Typically, electronic books can be cited the same way as print books. If the electronic version is different, include the URL.
